



CONTRACT OF AGENCY

This contract has been concluded between Flavon Group Kft. (located at 19 Veres Péter u., Debrecen H-4033, HUNGARY, company registry number: 09-09-011706, tax number: HU 13526456-2-09, represented by László Gaál) – as principal, hereafter referred to as the **Principal** – and:

as the agent, hereafter referred to as **the Agent**, under the following conditions, on the date indicated below:

1. The Principal authorizes the Agent to sell its products in compliance with the Flavon max Consumer Club Membership Agreement and the Regulation on Organization and Operation of the Flavon Group Kft. hereinafter the Organizational and Operational Regulations. Within this framework, the Agent is authorized to sell Flavon max products and enter into contract complying with the Flavon max Consumer Club Membership Agreement with a third party on behalf of the Principal, in accordance with the Principal's recommendations. The Agent is not entitled to sign any contract or document on behalf of the Principal. The Organizational and Operational Regulations shall form an integral part of the present contract, which the Agent has learnt and accepted.
2. The Agent accepts this mandate by signing the present contract.
3. The Agent declares that neither he/she nor his/her business enterprise pursue any similar commercial activity as agent in any other competing network. If this is not the case, the Agent is required to notify the Principal of that in advance in writing. If the Agent or his/her business wishes to become member of any other multi-level marketing network and sign a contract similar to the present one, he/she will ask Flavon Group Kft. for a prior written declaration of consent. Otherwise the Agent shall be deemed to have committed a breach of contract and shall be excluded from the system.
4. The Agent shall inform the Principal without delay of any changes in the data of the business he/she represents.
5. The Principal is liable for paying commission to the Agent after his/her activity he pursued as an agent, in compliance with the Organizational and Operational Regulations of the Flavon max Consumer Club. The Principal is also liable for supporting the Agent by providing him/her with leaflets and further materials related to the product, and for notifying the Agent on relevant matters.
6. The Principal is liable for preparing a commission report electronically, for providing the Agent with the report on the commissions due by sending an email to the email address provided by the Agent, and for disbursing it in return for an invoice.
7. This agreement is concluded for an indefinite period and either party may terminate it by notice, but exclusively for the end of the month. In this case, parties are required to settle accounts with each other.
8. In case of matters not regulated by this contract the provisions of the Civil Code of Hungary and the Act CXVII of 2000 shall apply.
9. The Parties shall endeavour to settle amicably the disputes arising from or in connection with the present contract. In the case of disputes which cannot be settled amicably, the Parties hereby submit, depending on the value of the litigation, to the exclusive jurisdiction of the Municipal Court of Debrecen or the Hajdú-Bihar County Court.

The Parties hereby declare that they have studied, understood and accepted the present contract, which reflects their contractual will in all respects.
